# Principal's Message

At Northview Intermediate School the philospohy of the staff and administration is that all students are entitled to a high quality education provided within a caring and supportive learning environment. In order to meet those goals a variety of strategies are employed to ensure the success of each and every student. The Student Success Team is an integral part of this "safety net" for students, involving a formal process to identify students demonstrating at-risk behavior. Our range of academic classes as well as our elective offerings, provide students with the opportunity to be challenged and motivated to learn. At Northview our staff and administration firmly believe that we are here to serve you our clients (students and their families) in an exemplary manner. We welcome you to our campus to experience first hand what the Northview family is all about. Intermediate school students face many challenges as they grow socially and academically, it is our job to do whatever it takes to help them be successful, this is why we welcome you to assist us in our endeavors as we support the youth of Duarte.

#### **Mission Statement**

At Northview Intermediate School it is our goal to provide a meaningful learning environment, which addresses the transition period between childhood and adolescence. We reognize that middle grade students are unique, encompassing a wide range of intellectual, physical, psychological, and social development.

Thus, the mission statment of Northview Intermediate is to meet the educational needs of each student in a culture of caring and respect. Northview's school motto is Believe, Achieve, Succeed!

#### **School Profile**

Northview Intermediate School is one of eight schools in the Duarte Unified School District, it is the only intermediate school serving all public school students in grades 7 and 8. Upon promotion, students from Northview then go to the one comprehensive high school, Duarte High School. Built adjacent to the high school and the Performing Arts Center, the school serves as the educational base for approximately 650 students. A traditional school year is followed at the intermediate school, along with the opportunity for

many students to attend a four week summer school session. Northview receives students from all sections of the community who come together for the first time academically and socially at this site. Consequently school demographics are diverse and representative of the entire district and community. The most numerically significant sub-group is Hispanic which represents more than 72.7% of the school population. The "White (Not Hispanic)" and the African-American populations comprise the next most numerically significant sub-groups. A variety of other ethnic groups such as Asian and Filipino make up the remaining student population. This diverse ethnic population affords the school the opportunity to promote cultural awareness and acceptance which is accomplished by schoolwide participation in activities that focus on similarities and promote appreciation of differences.

Northview students have access to supplemental materials, programs, and personnel from various categorical programs and the implementation of special programs on campus has contributed to a reduction in the "at-risk" population. All categorical programs are designed to support and extend the students' learning of the core curriculum. The programs Northview offers include AB 825 which provides an Outreach Consultant, and AB 1802 which funds an academic counselor. A variety of other before, during and after school intervention programs are offered which are funded through EIA/LEP, EIA/SCE, Special Education, Title II, and Migrant Education. An Honors program is also offered for students needing an accelerated course of study.

Northview has implemented a successful AVID (Advancement Via Individual Determination) Program for both 7th and 8th grade levels to promote a college bound culture for all students. Many of the strategies taught in AVID have been implemented schoolwide. Additionally, Northview students have benefited from the funds awarded to the site through the Enhancing Education Through Technology Grant (EETT). This grant provided funding for approximately 100 wireless lap top computers for student and staff use and provides access to an online writing program called Go My Access which provides students with instant feedback on their writing. Both use of technology and student writing skills have increased significantly as a result of this project.

# Discipline & Climate for Learning

Students at Northview Intermediate are guided by specific rules and classroom expectations that promote respect, cooperation, courtesy and acceptance of others. The goal of the Northview Intermediate discipline program is "to provide a safe, orderly and academically-focused environment in which students have the right to learn and teachers have the right and freedom to teach. This is accomplished through mutual respect and fair, consistent implementation of school policies." Parents and students are informed of school rules and discipline policies through the student agenda and copies of the school discipline plan that are sent home at the beginning of each school year. Expectation assemblies are held to review the discipline plan with students and many individual parent/ teacher/student conferences are held throughout the year to review these policies.

The Suspensions and Expulsions table illustrates total cases for the last three years, as well as a percentage of enrollment. Suspensions are expressed in terms of total infractions, not number of students suspended, as some students may have been suspended on multiple occasions. Expulsions occur only when required by law or when all other alternatives are exhausted.

Students are encouraged to participate in the school's additional academic and extracurricular activities, which are an integral part of the educational program. These school-wide and classroom incentives promote positive attitudes, encourage achievement, and aid in the prevention of behavioral problems. Extracurricular activities, clubs, and programs include: yearround after school sports program, debate, Renaissance, California Junior Scholarship Federation, Leadership, Yearbook/Newspaper, Band, Chorus, AVID and Think Together (an after-school program that focuses on academics and physical eduation). The school's interscholastic athletic programs promotes team-oriented achievement and self-esteem through school-sponsored teams that compete with other schools in the area as part of the highly competitive 210 Freeway League. Northview School recognizes and celebrates the achievements and successes of students and staff on a regular basis. Students are recognized for their achievements during quarterly awards ceremonies that parents are invited to attend and that are held during the school day and in the evenings. The AVID program has expanded to one 7th grade and one 8th grade class which helps to promote a college-bound philosophy used in every classroom. AVID strategies are used school-wide to impact the entire school population. The Outreach Consultant is responsible for coordinating most of these recognition events and they are instrumental in serving as motivation for our students.

#### Safe School Plan

Safety of students and staff is a primary concern of Northview Intermediate. The school is always in compliance with all laws, rules, and regulations pertaining to hazardous materials and state earthquake standards. The School Site Safety plan's last significant updates occurred October 2009 and were identified by the School Safety Committee. All revisions were communicated to both the classified and certificated staff. The school's disaster preparedness plan includes steps for ensuring student and staff safety during a disaster. Fire and disaster drills are conducted on a regular basis throughout the school year. Students are supervised before and after school by administrators and security staff, both classified and certificated/administrative staff supervise students during break and lunch. Parent volunteers also assist with supervision. There is a designated area for student drop off and pick up. Visitors are all "filtered" through the front office entrance and must sign in and receive a visitors name tag identifying them as a visitor to help monitor those on campus.

#### School Facilities

Northview Intermediate was originally constructed in 1989 through a cooperative joint effort between the City of Duarte and Duarte Unified School Districts and serves the students of two cities, Duarte and Bradbury. The site is comprised of 24 classrooms, one science lab, a classroom computer lab, multipurpose room, library, locker rooms, "canteen" cafeteria configuration, staff lounge, office complex, grass recreational field, blacktop recreation area and newly constructed gym. Recently the locker rooms were remodeled and new larger P.E. lockers installed, however the most significant improvement is the 4.4 million dollar gym completed in the fall of 2006. This gym allows Northview to showcase their fine athletic teams and provides indoor facilities for physical education during inclement weather. Community organizations and the city recreation department have also used the new gymnasium when not in use by school teams.

Cleaning and Maintenance Process: The administration works daily with the custodial staff that includes a full time head custodian and a full time night custodian to ensure that the cleaning of the school is maintained to provides a clean and safe school. District maintenance staff ensures that the repairs necessary to keep the school in good repair and work orders are completed in a timely manner. A work order process is used to ensure efficient service and highest priority are given to emergency repairs. While reviewing this report, please note that even minor discrepancies are reported in the inspection process. The items noted in the table have been corrected or are in the process of remediation.

# Staff Development

Staff members build teaching skills and concepts by participating in conferences and workshops throughout the year. A team approach to learning has been implemented as teachers interact and share their experiences and knowledge with district colleagues. The district has dedicated three full days to staff development annually. Topics for staff development during the 2008/09 school year included: Thinking Maps as graphic organizers for writing, AVID strategies such as Cornell Notes, organizational tools to use with students and Socratic Seminar. An additional focus has been placed on direct instruction and checking for understanding to be used as teaching strategies in all curricular areas. Also, all Departments are collaborating to ensure that their pacing schedules are updated and that benchmark assessments are routinely given to assess student master.

# **Teacher Assignment**

Duarte Unified recruits and employs the most qualified credentialed teachers. For the 2008/09 school year, Northview Intermediate had 100% fully credentialed teachers who met all credential requirements in accordance with State of California guidelines.

## Counseling & Support Staff

It is the goal of Northview Intermediate to assist students in their social and personal development as well as academics. The school gives special attention to students who struggling academically, have attendance issues, or are having difficulty coping with personal and family problems, trouble with decision making, or handling peer pressure. The Outreach Consultant and the AB 1802 Academic Counselor are the individuals primarily responsible for the coordination of services for "at-risk" students. Concerns expressed by staff, parents and/or students are filtered to these two individuals who are then responsible for scheduling parent conferences, Student Success Team meetings and are able tap into any resource services needed by the student. The counselor to pupil ratio is 1:325, this ratio is derived by including both academic counselor and Outreach Consultant. A memorandum of understanding has also been developed between Northview Intermediate School and Pacific Clinics and Family Foothill Counseling to provide individual counseling services for eligible students. #### At Risk Interventions

Northview Intermediate provides after-school tutoring in English/Language Arts and Mathematics for those students performing below grade-level standards or who are at risk of retention. Other intervention programs offered at Northview Intermediate include: Peer Tutoring (3 days per week), teacher guided assistance before and after school, and CST test prep classes. Intervention and assistance is available for all students to ensure their academic growth and success.

# **English Language Learners**

Northview Intermediate offers our English Language Learner (ELL) students the assistance through the following programs: High Point and Rosetta Stone. Students still needing to develop oral and written fluency skills in English are placed in a self-contained ELD class for 3 periods per day. Students with intermediate level fluency are provided support in literature based ELD English classes that emphasize written language skills and vocabulary enhancement. Student's needs are evaluated on an ongoing basis to ensure their success. Evaluation is conducted through the CELDT (California English Language Developement Test), academic grades, school benchmarks and teacher input.

#### **GATE**

Differentiated instruction is the hallmark of an effective classroom. DUSD teachers, in their never ending strive for excellence, have been trained to meet the unique needs of their students with the use of varied and unusual instructional methods. All teachers have gone through specific professional development to sensitize them to the needs of their gifted students in their everyday lesson design and delivery.

At the intermediate and secondary levels, gifted and high achieving students participate in honors classes, and a whole host of advanced placement classes in math, language arts, art and social science. Students at the intermediate level are clustered for specially designed classes and at the high school, the open enrollment policy, allows for access to all students that desire the opportunity to participate in the most "rigorous and challenging" curriculum available.

#### **Additional Internet Access/Public Libraries**

For additional research materials and Internet availability, students are encouraged to visit the public library located in the citiy of Duarte, which contains numerous computer workstations. The library offers a wonderful live tutor homework helper for all students to receive assistance with homework. Also, the Northview Intermediate library offers internet access to students daily during break, lunch and after school until 4:30pm. Students also have access to the internet via classroom laptops which they use in all curricular areas for research and presentation purposes.

#### **Instructional Materials**

Duarte Unified held a Public Hearing on October 8, 2009, and determined that each school within the District has sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the State Department of Education, making the textbooks used in the school the most current available.

Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. The table displays information about the quality, currency, and availability of the standards-aligned textbooks and other instructional materials used at the school.

#### Parent Involvement

Northview Intermediate School has a long tradition and on-going commitment to building strong connections to our parents and the community. In order to foster these connections and to expand the base of active parent support, parent input is sought throughout the school year. Parents plan, implement, and evaluate all elements of the educational program including: governance; funding allocations, the organization of supplementary student support services; student assessment reporting and the annual updating of the comprehensive school plan. Northview Intermediate maintains a School Site Council whose membership includes equal representation of parents, students, and staff. The Council assists in the planning, monitoring and evaluation of the School Plan, including the categorical budget. The Council elects voting members, but all students and parents are invited to attend by well-publicized notices. Northview Intermediate also has an active Parent-Teacher-Student Association (PTSA). It serves as a support group for school functions and programs throughout the year. On a daily basis parents are able to be informed of school activities and monitor student progress utilizing the agenda that is provided to all students by the school each year to facilitate home-school communication. Also, parents have access to the school website (www. edline.net) which keeps them informed of activities, students progress and gives them an opportunity to communicate to teachers via teacher created websites. Nothview has also conducted a variety of parent workshops called "Parent Power" which cover the topics of discipline, student achievement, college, math help and other various information topics. In an attempt to promote greater communication and collaboration all parents are invited district-wide to the workshops. Parents also receive a varieity of literature on events and school news. Newly implemented is the Autodialer program which allows the school site to call home automatically to report absences, extend invitations and to inform parents of a variety of school events.

# **California Standards Test**

The California Standards Test (CST), a component of the STAR Program, is administered to students in the spring to assess student performance in relation to the State Content Standards. Student scores are reported as performance levels: Advanced (exceeds state standards), Proficient (meets standards), Basic (approaching standards), Below Basic (below standards), and Far Below Basic (well below standards). The combined percentage of students scoring at the Proficient and Advanced levels in English/Language Arts, Math, Social Science, Science, for the most recent three-year period, is shown. Summative scores are not available for Math (grades 8-11), Science (available for grades 5 and 8 only), and grades 8, 10 and 11 in Social Science. #### **Academic Performance Index**

The Academic Performance Index (API) is a score on a scale of 200 to 1,000 that annually measures the academic performance and progress of individual schools in California. On an interim basis, the state has set 800 as the API score that schools should strive to meet. Statewide Rank: Schools receiving an API Base score are ranked in ten categories of equal size (deciles) from 1 (lowest) to 10 (highest), according to type of school (elementary, middle, or high school). Similar Schools Rank: Schools also receive a ranking that compares that school to 100 other schools with similar demographic characteristics. Each set of 100 schools is ranked by API score from 1 (lowest) to 10 (highest) to indicate how well the school performed compared to similar schools.

# **National Assessment of Educational Progress**

The National Assessment of Educational Progress (NAEP) is a nationally representative assessment of what America's students know and can do in various subject areas. Assessments are conducted periodically in mathematics, reading, science, writing, the arts, civics, economics, geography, and U.S. history. Student scores for reading and mathematics are reported as performance levels (i.e., basic, proficient, and advanced) and the participation of students with disabilities (SD) and English language learners (ELL) is reported based on three levels (identified, excluded, and assessed). No Child Left Behind (NCLB) is a federal law enacted in January 2002 that reauthorized the Elementary and Secondary Education Act (ESEA). It mandates that all students (including students who are economically disadvantaged, are from racial or ethnic minority groups, have disabilities, or have limited English proficiency) in all grades meet the state academic achievement standards for Mathematics and English/Language Arts by 2014. Schools must demonstrate "Adequate Yearly Progress" (AYP) toward achieving that goal. The federal NCLB Act requires that all schools and districts meet the following Adequate Yearly Progress (AYP) requirements:

- · Participation rate on the state's standards-based assessments in English/Language Arts (ELA) and Mathematics.
- Percent proficient on the state's standards-based assessments in ELA and Mathematics.
- · API as an additional indicator.
- · Graduation rate (for secondary schools).

There are several consequences for schools that do not meet the AYP standards, including additional tutoring and replacing of staff. Students would also be allowed to transfer to schools (within their district) that have met their AYP's, and the former school would be required to provide the transportation to the new site. Results of school and district performance are displayed in the chart.

# **Federal Intervention Program**

Schools and districts receiving federal Title I funding enter Program Improvement (PI) if they do not make AYP for two consecutive years in the same content area (English/Language Arts or Mathematics) or on the same indicator (API or graduation rate). After entering PI, schools and districts advance to the next level of intervention with each additional year that they do not make AYP. Northview does not receive Title I funds.
